### COMPETITION TERMS AND CONDITIONS

1. These Terms and Conditions and all other information provided prior to entering the Competition, including the Schedule and any instructions on how to enter the Competition form part of these Terms and Conditions. The Schedule defines certain terminology used within these Terms and Conditions. To the extent of inconsistency between the Schedule and these Terms and Conditions, the Schedule prevails.
2. Entry is only open to residents of Relevant States who comply with the Entry Restrictions (if any) and have a valid email address.
